### The New OACFDC Website — Coming Soon!

The old website at <a href="www.oacfdc.com">www.oacfdc.com</a> was started in October 1998. Initially there were two different websites: One for promoting the Community Futures program and one for the OACFDC. Eventually, the two were combined and over the years, it was added to many times.

In recent years, concerns have been raised about the old website:

- difficult to find anything, especially in the Members' Area
- not well organized
- not user friendly
- outdated "look & feel"
- does not rank well with search engines

Based on those concerns, an RFP was circulated in January, seeking a website developer to create a new site. Laura Rey, a contractor who had been maintaining the OACFDC's To Learn Online website (www.tolearnonline.ca & www.apprendreenligne.ca), was the successful bidder.



The new website will have 3 main areas:

- 1. All about the **Community Futures Program** This area will have information for the general public, along with Success Stories, Media Releases and other information promoting the CF program.
- 2. All about **the OACFDC** the general public will be able to learn the basic information about the OACFDC, and also where members must log in. Depending on their position, members will be logged in at different levels:
  - Public
  - Associate Members
  - Bilingual
  - FedDev/FedNor
  - CFDC Board Members
  - CFDC Employees
  - CFDC Managers
  - Students
  - CFDCs which are not members of the OACFDC (Provides access only to the FedNor and FedDev Ontario information
  - OACFDC (with separate categories for OACFDC Board of Directors, Employee, Executive Assistant, Executive Director, Member Services Coordinator)

Once members log in, they will be able to see links to all the information they need, based on their position.

3. **To Learn Online** – the OACFDC's e-learning platform which has existed on its own website. However, it, too, needed upgrading so we are moving it over to the OACFDC website. Maintenance of all the information can be more economically achieved under one website.

The new website will be better organized so that information will be readily found. There will not be a "Members' Area" as such: Information will be visible to the user, depending on the users' log in/password combination.

The Events Calendar will be visible in both the "CF Program" section and the "OACFDC" section. Then, for example, a CFDC might post an event for interested potential entrepreneurs to attend. That event will show up on both sections of the website. But if a CFDC was hosting a training session for only CFDC board members, it would only show up on the OACFDC side.

In the OACFDC area, there will also be a forum for board members to ask questions, post information and share ideas with each other.

There will be various interactive features that members can use themselves – newsletter and emailing systems that all members can use, or posting important dates on the calendar. Members will be receiving guides outlining the procedure, or they can plan to attend the workshop at the Conference in September where website developer Laura Rey will be presenting this information.

Once the new website is populated with the information from the old website, information of interest to the general public will be "tagged", to improve its standing on search engines. (Also known as SEO or Search Engine Optimization). So when the general public is searching in Google, or similar search engines, for small business loans, for example, the SEO will ensure that CFDC information pops up first or very high on their list of findings.

Due to the tragic and sudden death of our former website developer, Doug Maddock, we will not have access to the old website after July 31. We hope to have the new website "live" by July 23.

As the framework for the website is nearing completion, is there anything in addition to the items mentioned above that OACFDC members would like to see on the website?

Due to the risk of a virus infection and the security and confidentiality of information, it is imperative that all active devices are updating regularly to obtain the latest virus definitions from the VisionQuest service.

We are pleased to relay that the latest round of notifications and alignment with 16 CF offices was a huge success. 13 offices responded, of which 7 offices have been successfully cleaned up and aligned... 6 offices are in progress. Inactive devices were removed from monitoring for the 3 CFs that did not respond. Thank you for your cooperation.

#### **Latest Release of Software**

CommonGoals has received some pretty amazing feedback regarding the latest release of the software. With the deployment of the Ribbon toolbars and the addition of enhanced views, summary data and searching, the database has never been easier to use or provided so much information at your fingertips.

## Income Tax Services for Small Business

This year Canada Revenue Agency did a pilot project with Atikokan Economic Development Corporation, where they sought retired accountants to volunteer their services preparing income tax forms for small business owners at no charge. Watch for information about the future of this project.

CRA is also seeking feedback on the newly developed **Checklist of Small Businesses**.

As part of its efforts to cut red tape, the CRA is committed to engaging businesses and their stakeholders regularly, and through many avenues, in an effort to make sure CRA services continue to meet their needs.

Following a Webinar for new small business owners offered in the fall of 2013, as well as consultations with different small business owners and self-employed individuals, the CRA has created a Small Business Checklist that provides information on some of the key tax topics that should be taken into consideration throughout your business' lifecycle, in a user-friendly manner on the CRA website. The recommendations and feedback received over the course of the consultations were crucial to the creation of this document.
